I certify that I have received a copy of the Conditions of Use refund policies and regulations of use of Borough parks. I am aware that I will be sent a copy of any changes to these rules. I further understand that any expenses to the borough related to damages to park facilities or violations of park ordinances will result in a deduction from the security deposit and subject me to further fines and penalties as outlined in the Borough of Swissvale ordinances.

The information I have provided is true and correct to the best of my knowledge. I understand that this permit can be revoked, all fees forfeited and my event terminated for falsification of information or failing to comply with park rules and ordinances.

REFUND POLICY:

- Fees are refundable if applicant informs Borough of Swissvale Administrative Offices of cancellation not less than thirty (30) days prior to event.
- Failure to clean the park after event will result in a forfeiture of the full security deposit.
- Refunding of security deposits is handled through the borough and will be mailed to the permit holder within 4-6 weeks after the scheduled event.

NOTE: The ball field CANNOT be used after heavy rains because of difficulty in fixing fields that have footprints in them and related damage that can occur – contact the borough prior to use if you are unsure as to whether the ball field is available.

The applicant further agrees to hold the Borough of Swissvale free and harmless from any liability of any nature resulting from the consumption of any alcoholic beverages by any and all persons attending the permitted event.
